TRANSFER OF OWNERSHIP AGREEMENT

This TRANSFER OF OWNERSHIP AGREEMENT is dated _____, _____, and is from the undersigned person(s) (the "*Transferor*") to and in favor of the Lakeshore Pembroke Welsh Corgi Rescue, Inc. ("*LPWCR*") and its successors and assigns.

1. *Transferor*, for the sum of \$1.00 and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, hereby voluntarily and irrevocably transfers ownership and possession of the Pembroke Welsh Corgi described below ("*Corgi*") to *LPWCR*. *Transferor* hereby forever relinquishes all rights of ownership in and claims to *Corgi*. *Corgi* is described as follows:

2. *Transferor* represents and warrants to, and agrees with, *LPWCR* and its successors/assigns, that:

- _____ a. *Transferor* is sole owner of *Corgi*, and has full right and power to transfer *Corgi* to *LPWCR*. *Transferor* has carefully considered for a sufficient period of time all available options for *Corgi*, has discussed such options with all persons who might be affected thereby, and has determined that the transfer of *Corgi* to *LPWCR* is in the best interests of *Transferor* and *Corgi* and is final. *Transferor* hereby gives to *LPWCR* all registration papers issued for *Corgi*.
- _____ b. *Transferor* fully understands that *LPWCR* will determine, in its sole discretion, the appropriate actions to be taken with respect to *Corgi*, which actions could include (1) the neutering or spaying of *Corgi*, (2) the ownership and physical custody of *Corgi* being transferred by *LPWCR* to an unknown third party, and/or (3) humane euthanasia in the event that *LPWCR* determines that *Corgi* is unsuitable for adoption.
- _____ c. *Transferor* certifies that all information about *Corgi* known to *Transferor* is shown on the attached page, which information is correct and complete and is not misleading in any respect. *Transferor* further certifies that *Corgi* does not have any dangerous or vicious traits and has not threatened, attacked, bitten or otherwise harmed any person or animal, except for any such traits or

occurrences that are described and explained on the attached page.

In consideration of the acceptance by *LPWCR* of *Corgi*, *Transferor* hereby releases, indemnifies and holds harmless *LPWCR* and its members, officers, directors, employees and agents from any and all losses, claims, damages, liability, actions or expenses (including reasonable attorneys' fees and other legal costs) of every nature imposed on, incurred by or asserted against any of them, whether direct, indirect or consequential, arising as a result of, or in any way relating to, *Corgi's* actions, care, adoption or disposition.
